- The product is listed in Part 7S of the Scottish Drug Tariff.
- The product can be sourced from NHS manufacturing units in Scotland, England or Wales.
- Previous authorisation has been obtained in the last 12 months and, the patient, the GP practice, the product, the supplier and the cost are all unchanged. Re-authorisation is required if the price increases by > 20% (or if anything else changes in the prescription).

GPs should contact their local community pharmacist or local Prescribing Support Team for advice.
